RE: **FORMAL NOTICE – CEASE AND DESIST**
(Defamatory publications concerning Gecić Law / Bogdan Gecić)

Dear Sirs,

We act for Gecić Law and its partners (“**Gecić Law**”). This letter concerns your outlets’ repeated publications since August 2025, and the intensified series of articles published between 9 and 13 January 2026, which allege and/or insinuate (among other things) unlawful or unethical conduct, conflicts of interest, political collusion, and misuse of confidential information by Gecić Law and its lawyers (the “**Publications**”).

On 12 January 2026, your reporter sent questions stating we were promised 48 hours to respond; nevertheless, further accusations were published within hours, without a fair opportunity to reflect our position and without substantiated factual basis.

The Publications contain false statements and defamatory insinuations, and they improperly attack the role and independence of legal counsel while encouraging interference with attorney-client confidentiality and privilege. They cause serious reputational and commercial harm.

In accordance with our professional obligations, Gecić Law does not comment on client matters, alleged communications, or documents, nor do we confirm or deny client relationships or the scope of any engagement. All work performed by Gecić Law fully complies with applicable legal, ethical, and professional standards, including the strictest rules on confidentiality and conflicts of interest. Any suggestion to the contrary is baseless.

DEMANDS:

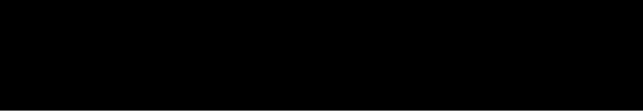
- 1) Immediately CEASE AND DESIST from any further publication, republication, or promotion of the defamatory allegations and insinuations concerning Gecić Law, Mr. Gecić, and our lawyers.
- 2) Immediately remove and/or correct the Publications and publish a prominent retraction and apology, or at minimum an equally prominent correction confirming that no breach of law or legal-ethics rules by Gecić Law has been established.
- 3) Refrain from soliciting, publishing, or relying upon any material that is or may be protected by legal professional privilege or confidentiality.
- 4) Preserve all evidence relating to the Publications, including notes, recordings, messages, emails, drafts, version histories, metadata, and communications with sources (litigation hold).

Please provide written confirmation of compliance within 48 hours of receipt of this notice. If you fail to do so, we will pursue all available remedies (including urgent injunctive relief and damages and/or penal actions if necessary) in all relevant jurisdictions, without further notice.
